| WHY?  | Financial companies choose how they share your personal information. Federal law gives con-<br>sumers the right to limit some, but not all sharing. Federal law also requires us to tell you how<br>we collect, share, and protect your personal information. Please read this notice carefully to<br>understand what we do. |

| WHAT? | The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul> <li>social security number and assets</li> <li>account balances and payment</li> <li>history credit history and credit scores</li> </ul>  |
| HOW?  | All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Cove Federal Credit Union chooses to share; and whether you can limit this sharing.             |

| How does Cove FCU protect my personal information?  | To protect your personal information from unauthorized access<br>and use, we use security measures that comply with federal law.<br>These measures include computer safeguards and secured files<br>and buildings.   |
| How does Cove FCU collect my personal information?  | <ul> <li>We collect your personal information, for example, when you</li> <li>open an account or deposit money</li> <li>apply for a loan or provide account information</li> <li>use your credit or debit card</li> <li>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</li> </ul>  |
| Why can't I limit all sharing?  | <ul> <li>Federal law gives you the right to limit only <ul> <li>sharing for affiliates' everyday business purposes information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for non-affiliates' to market to you</li> </ul> </li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul> |
| What happens when I limit sharing for<br>an account, I hold jointly with<br>someone else? | Your choices will apply to everyone on your account.   |

| Affiliates      | Companies related by common ownership or control. They can<br>be financial and nonfinancial companies.<br>OUR AFFILIATES INCLUDE COMPANIES WITH A COMMON CORPORATE<br>IDENTITY OF COVE FCU.         |
| Nonaffiliates   | Companies not related by common ownership or control. They<br>can be financial and nonfinancial companies.<br><i>COVE FCUDOES NOT SHARE WITH NONAFFILIATES SO THEY</i><br><i>CAN MARKET TO YOU.</i> |
| Joint marketing | A formal agreement between nonaffiliated financial companies<br>that together market financial products or services to you.<br><i>OUR JOINT MARKETING PARTNERS INCLUDE INSURANCE COMPANIES.</i>     |
